All the registered candidates for the said Examination are advised to visit the website (<https://jeemain.nta.nic.in/>) and verify their particulars. They are further advised to make correction/s in their particulars, in their respective Application Form, if required.

The candidates are allowed to make the corrections, latest by 27 November 2024 (up to 11:50 P.M.). Thereafter, no correction in particulars, whatsoever, will be entertained by NTA under any circumstances. The additional fee (wherever applicable) shall be paid by the candidate concerned either through Credit/Debit Card/Net Banking/UPI.

Since it is a one-time facility extended to the candidates to avoid any hardship, the candidates are advised to do the correction very carefully, as no further opportunity for correction will be given to the candidates.

**LAST DATE FOR SUBMISSION OF ONLINE APPLICATION FOR JEE (MAIN) 2025 IS 22 NOVEMBER 2024 AND THERE WILL BE NO FURTHER EXTENSION OF DATE.**

5.	Candidate shall be allowed to change <b>all</b> the fields:	i. Date of Birth ii. Gender iii. Category iv. Sub-category / PwD v. Signature
6.	Candidate shall be allowed to add the field:	i. Paper
