#### **Note:-**

1. For the above mentioned vacancies, reservation for SC/ST/OBC/PWD/EWS categories will be applicable as per provisions of Ministry of Skill Development and Entrepreneurship, Central Apprenticeship Rules, Apprentices Act 1961, Apprenticeship Rules, 1992 and Apprenticeship (Amendment) Rules, 2015 & 2019.
2. The number of vacancies mentioned above is only indicative and may change at a later stage depending on the final assessment of eligible applications received.

#### **Part - 1 Important Instructions :**

1. The engagement and training will be strictly in accordance with Apprentices Act, 1961, Apprenticeship Rules and its amendments from time to time and **there is no obligation for employment of apprentices on completion of their training.**
2. The tenure of the Apprenticeship for the above categories / trades would be **12 months** commencing from execution of the contract of Apprenticeship
3. Registration of (i) **BE / B.Tech / Diploma (Engineering) & B.Com / B.Sc / B.A / BCA / BBA (Non Engineering)** candidates on (<https://nats.education.gov.in>) and (ii) **ITI candidates** on Apprenticeship portal ([www.apprenticeshipindia.org](http://www.apprenticeshipindia.org) or [www.apprenticeshipindia.gov.in](http://www.apprenticeshipindia.gov.in) ) is mandatory. Kindly see respective websites for registration. The registration No. is required to be mentioned while filling the application form.
4. The above registration No. is liable to be verified at the time of selection / Document verification.

5. **For B.E / B.Tech / Diploma (Engineering - Apprentice Trainees) & B.Com / B.Sc / B.A / BCA / BBA (Non Engineering -Apprentice Trainees);** Candidates who have passed in the year **2021 / 2022 / 2023 / 2024 / 2025 (last five years)** as regular candidates are only eligible to apply. Candidates who have passed the qualifying exam earlier than year **2021** are not eligible.
6. **Candidates with higher qualification are not eligible to apply.**
7. OBC certificate whose validity has expired would not be accepted for granting concession.
8. **ITI Apprentice Trainees only;** Candidates must have completed ITI from NCVT or SCVT Boards.
9. Applications of those candidates who have appeared in the qualifying examination, but whose results have not been declared / available as on the date of advertisement will **NOT** be considered for training. Provisional Degree Certificates of qualifying exam would however be acceptable during the time of joining, but final degree certificates shall have to be submitted as & when received for verification and acceptance.
10. Suppression of facts will lead to disqualification, at any stage of the selection process or during the training period.
11. Those candidates who have completed the qualifying examination as **regular candidates are only eligible to apply.**

16. **No TA/DA shall be given to the candidates for interview / Document verification / joining GTRE as Apprentice Trainees.**
17. **The Apprentice Trainees will not be provided any quarters / hostel accommodation by this establishment at the time of interview and also during the training period.**

**Part - 2 Stipend :**

Candidates finally selected for the Apprenticeship Training would be eligible for stipend as given below as per Govt. of India rules:

**(i) Engineering Stream:**

- Graduate Apprentice (B.E./B.Tech./Eqvt.) : Rs.9000/- per month
- Diploma Apprentice : Rs.8000/- per month
- ITI Apprentice : Rs.7000/- per month

**(ii) Non Engineering - General Stream:**

Graduate Apprentice (B.Com./ B.Sc. / B.A / BCA / BBA): Rs.9000/- per month

**Part - 3 Medical Fitness :**

The candidate should possess satisfactory health. Candidates finally selected will have to produce Fitness Certificate issued by authorized Medical officer of any Government Hospital as per GTRE specified format during joining time. Certificate issued by ESIC hospitals will **NOT** be accepted. Final selection of the candidate depends upon his/her fulfilling health standards as prescribed in Apprentices Act, 1961 and Apprenticeship Rules 1992 as amended from time to time.

1. **Graduate Apprentice Trainees – Engineering (B.E / B.Tech / Equivalent), Graduate Apprentice Trainees - Non Engineering (B.Com / B.Sc / B.A / BCA / BBA), Diploma Apprentice Trainees / ITI Apprentice Trainees:** Depending upon the vacancies available in various disciplines, selection of candidates will be carried out by short listing on the basis of Academic Merit, subject to satisfactory verification of the documents.
