## VACANCY CIRCULAR

### FILLING UP THE POST OF INSPECTOR (ACCOUNTANT) GROUP "B" POSTS (NON-GAZETTED), (COMBATANT MINISTERIAL) POST ON DEPUTATION / ABSORPTION BASIS IN ITBP.

Applications are invited for filling up the following Group "B" posts in I.T.B.P. on deputation/absorption basis. Details of post/vacancy and eligibility conditions are as under:-

#The vacancies are subject to change (decrease or increase) at any stage.

2. The eligibility and other conditions for appointment to the post of Inspector (Accountant) on deputation/absorption basis are as under:-

#### By Deputation:

(A) (i) From amongst Inspector (Combatant Ministerial) in level-7 of the Pay Matrix of Indo- Tibetan Border Police Force OR From amongst Sub-Inspector (Combatant Ministerial) of Indo-Tibetan Border Police Force in level-6 (Rs. 35400-112400) in the pay matrix with five years regular service in the grade;

(ii) Officers from Central Government Ministries or Departments holding analogous posts on regular basis; OR Officers of the Central Government with five years regular service in Level 6 (Rs. 35400-112400) in the pay matrix.

(iii) Departmental Assistants with five years regular service in Level 6 (Rs. 35400- 112400) in the pay matrix. **AND**

(B) Having successfully qualified in the Cash and Accounts Course conducted by the Institute of Secretariat Training and Management and possess minimum three years experience in cash, accounts and budget work;

(C) The Medical Category for above post is **SHAPE-1**

**Note. 1-** The period of deputation including the period of deputation in another **ex-cadre** post held immediately preceding this appointment in the same or some other Organization or Department of the Central Government shall ordinarily not exceed five years. The maximum

age-limit for appointment by deputation shall not be exceeding fifty-six years as on the closing date of receipt of application.

**Note. 2-** The Inspector (Combatant Ministerial) of Indo-Tibetan Border Police Force who have selected for appointment on deputation basis, shall only be considered for absorption.

#### (B) Pay & Allowances:-

The pay & allowances of the official selected for appointment on deputation basis will be regulated in accordance with Department of Personnel & Training, OM No.6/8/2009/Estt.Pay-II dated 17-06-2010.

#### (C) ABSORPTION:-

The Inspector (Combatant Ministerial) of Indo-Tibetan Border Police Force who has been selected for appointment on deputation basis, shall only be considered for absorption to the post of Inspector (Accountant). Eligibility Criteria for absorption from Inspector (CM) to the rank of Inspector (Accountant) are as under:-

(i) One year regular service as Inspector (Accountant) on deputation basis in ITBP.

(ii) The willingness of individual for absorption to the post of Inspector (Accountant) along with recommendation of concerned Head of Office.

(iii) Medical Category- SHAPE-1

(iv) No DE/Vigilance case is pending or being contemplated certificate by H.O.O.

(v) His integrity should be beyond doubt.

(vi) Not adverse remark in APAR for last 5 years.

(vii) No major punishment during last 5 (five) years and no minor punishment during last 01 (one) year awarded to individual.

#### (D) DEBARRED:-

i) If any Inspector (CM) of ITBP who have been selected as Inspector (Accountant) on deputation basis will submit unwillingness for absorption to the post of Inspector (Accountant) will be **debarred** for absorption as Inspector (Accountant) in future.

ii) An Inspector (CM) of ITBP who has earlier been debarred for deputation/absorption to the post of Inspector (Accountant) based on his unwillingness shall not considered for appointment as Inspector (Accountant).

**(E) Other Conditions:-**

- (i) The selected persons shall be liable to be posted anywhere in India.
  - (ii) The post of Inspector (Accountant) in ITBPF is combatised. The ITBPF Act-1992 and ITBPF Rules 1994 shall apply to the persons appointed/selected for deputation/absorption.
  - (iii) Selected persons shall be allowed to draw Uniform Maintenance Allowances as admissible under the Rules. Salary will be subject to deduction of normal income tax as applicable to civil officers. Visit to "[KarnatakaHelp.in](http://KarnatakaHelp.in)
  - (iv) The officer will be entitled for Leave Travel Concession: as per CCS (LTC) Rules, 1988 as amended from time to time.
3. Applications through proper channel of willing and suitable persons along with their Bio-data in the prescribed proforma (given) as Annexure-II together with up-to-date ACR/APAR dossiers (attested copies each page) for the last 05 years i.e 2019 to 2023, DE/Vigilance Clearance Certificate, and Integrity Certificate should reach **“Sr. Admn. Officer (Estt), Directorate General, ITBP, MHA/Govt. of India, Block-2, CGO Complex, Lodhi Road, New Delhi-110003”** by 21 November, 2025. Persons once nominated will not be permitted to withdraw their candidature.
