### 1. Requisite Qualification:

- Should possess/ acquire Degree from a recognized University/ Institution of Karnataka (Recognized by State Govt./Central Govt./AICTU)
- Should Possess/ acquire 3 year Diploma from a Polytechnic College/ Institution of Karnataka (Recognized by the State Govt./ Central Govt.)

### 2. Eligibility Criteria:

- The candidate should have Degree/ Diploma certificate or Provisional Degree/ Diploma Certificate before last date of application submission.
- The candidate should have scored minimum passing marks and obtained a Degree/ Diploma on or after January 2021.
- The candidates who have already undergone or are currently undergoing apprenticeship training under Apprenticeship Act 1961, and/ or having one-year work experience are not eligible to apply.
- Age limit should not be less than eighteen years of age as per Apprenticeship Rule.

### 3. Guidelines under Apprentices Act on Reservation for SC/ST/OBC will be adhered to. The category/ reservation claimed during the initial online submission of application only will be considered. The candidates will have to produce the relevant certificate in support of the category/ reservation claimed at the time of verification of document failing which their claim for reservation will be considered as GENERAL category only. Candidate claiming OBC reservation should produce a separate OBC certificate (Income cum caste certificate will not be accepted).

### 4. MINIMUM PHYSICAL STANDARDS:

A candidate should be free from evidence of any contagious or infectious disease. He should not be suffering from any disease, which is likely to be aggravated by service or is likely to render him unfit for service or to endanger the health of the public. He should also be free from evidence of tuberculosis in any form, active or health as per Apprenticeship Act specified in Schedule-II. He/ She shall produce medical fitness certificate issued in writing by a Medical Officer not below the rank of an Assistant Surgeon.

### 5. DURATION OF TRAINING:

The duration of Apprenticeship training will be for a period of one year as per Apprenticeship Act 1961.

## 6. SELECTION PROCEDURE:

Board of Apprenticeship Training (Southern Region) is entrusted with the task of preparation of shortlisting the candidates from online application data. Shortlisting process will be done based on the marks secured in the Qualifying examinations only. Shortlisted candidates will be intimated through their registered Email ID. They will have to appear in person for verification of documents at the **O/o The Deputy General Manager (Human Resource Development), Training and Research Institute, BESCO, opposite to Tree Park, Behind BGS World School, B.M. Road, Ramanagara, Bangalore South District-562159.**
